Mayor Bouziga called this meeting to order at 7:00 P.M.

Councilman Frank Boura presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the Town meeting held on Monday, September 12, 2011. The Council unanimously approved the motion as presented.
