The Mayor and Council of the Town of Golden Meadow met for their regular scheduled special meeting on Monday, October 17, 2011 at 7:00 PM at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Others attending were Kiley Adams, Chief Randy Chiasson, Lloyd Ledet, Sybil Ledet, Cindy Lefort, Parish Councilman Daniel Lorraine, Betty Plaisance, John Plaisance, Johnny Plaisance, and Willis Toups.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the Town of Golden Meadow's meeting held on October 3, 2011. The Council unanimously approved the motion as presented.

Chief Randy Chiasson presented the September 2011 police stats. Councilman David Adams asked Chief Chiasson to report at the next meeting stats on thefts solved during 2011.

Chief Chiasson also reported that laptops have been installed in police units.

Mayor Joey Bouziga presented a building permit for Ordoyne Griffin. Mr. Griffin is going to make a request for a building permit to replace an already existing mobile home. He is four hundred feet from the nearest sewer manhole. A motion was presented by Councilman Jody Cheramie and seconded by Councilman David Adams to table a decision whether to have Mr. Griffin tie into the Town's sewer system or purchase his own sewer plant powered by a lift station until the next Town Council meeting. The Council unanimously approved this motion as presented.

An occupational license for Golden Meadow Mini Storage was presented by Mayor Joey Bouziga. A motion to approve this occupational license was presented by Councilman Frank Boura and seconded by Councilman David Adams.

Mayor Bouziga presented the clean-up report as follows:

- Harris Kieffe Estate off Palmetto Lane- not cleaned A motion was presented by Councilman Jody Cheramie and seconded by Councilman Frank Boura to have the Town clean this property. The Council unanimously approved the motion as presented.
- Tal Griffin 131 Lot 1 Dursette Street and Nicholas Billiot 135 Dursette Street clean up complaint was received. A motion was presented by Councilman David Adams and seconded by Councilman Frank Boura that Town Attorney Mithell Theriot look into the nature of the complaint and the zoning of this property and send a letter to Mr. Eugene Chiasson the property owner. The Council unanimously approved the motion as presented.

Mayor Bouziga presented the dangerous building report as follows:

 Lincoln Martin, Sr. – 115 Mrs. Thomas Pitre Lane- no response received- A motion was presented by Councilan Mike Billiot and seconded by Councilman Priscilla Mounic to advertise for bids to clean up this building. The Council unanimously approved this motion as presented.

Town Engineer John Plaisance presented project updates as follows:

- Sewer Phase III South Central Planning acquiring right-of-ways.
- Sewer Phase IV Work continues on surveying.
- Sewer Phase V South Central Planning is preparing application for funding.
- Seawall Phase II Waiting geotechnical review to be ready at end of week.
- Waterlines in Oakridge Park Will meet with Lonny next week. Should be ready to advertise for bids by Thanksgiving.

A motion was presented by Councilman Jody Cheramie and seconded by Councilman David Adams approving Resolution No. 1472 authorizing Mayor Bouziga to sign an application for funding from LGAP for a fuel station. The Council approved this motion as presented.

Mayor Bouziga reported that the request for a turn-around near the new location of Frank's SuperValu has been denied by the Department of Transportation and Development. Mayor Bouziga stated that the next step is to contact our Representatives to try to acquire this turn-around. Councilman Frank Boura reported that a representative from DOTD will be visiting the Frank's SuperValu area tomorrow to evaluate the situation.

Mr. Willis Toups requested a parade permit for the Veterans Day Parade on November 7, 2011 on LA #1 from Golden Meadow Middle School south to the American Legion Hall beginning at 10:30 AM. A motion to grant this parade permit was presented by Councilman David Adams and seconded by Councilman Jody Cheramie. The Council unanimously approved this motion as presented.
