The Mayor and Council met for their regular scheduled meeting on Monday, December 17, 2012 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Bouziga called the meeting to order at 7:00 P.M.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the meetings held on December 3, 2012 and December 10, 2012. The Council unanimously approved the motion as presented.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Mayor Bouziga informed the Council no building permits or Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the dangerous building report as follows:

The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a request be sent to the building inspector and a letter be sent once the inspectors report is received. Mayor Joey Bouziga informed the Council, he met with Terry Arabie from Lafourche Parish, and Ben Hodson representing Picciola & Associates to inspect Phase III of the

The Council unanimously approved the motion as presented.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded authorizing Mayor Joey Bouziga be appointed as the Town representative on the Parish Emergency Management Advisory Committee. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested audience comments.

Ms. Alice Griffin and Ms. JoAnne Griffin addressed the Council regarding a sex offender who recently moved into Golden Meadow. A lengthy discussion took place. Mayor Bouziga requested the Council authorize the new Town Attorney review the laws regarding sex offenders. Councilman Frank Boura presented a motion and Councilman Jody Cheramie seconded authorizing the new Town Attorney review sex offender laws. The Council unanimously approved the motion as presented.

Mr. Robert Lee asked if any additional precautions have been set in place at the Golden Meadow Schools due to the recent Connecticut incident. Chief Reggie Pitre stated Lafourche Parish Sheriff's Office does have an officer assigned to the schools. Chief Reggie Pitre also stated Lafourche Parish School Board does not want any disruptions in schools in Lafourche Parish due to the recent incident.

Mr. Chet Louviere requested assistance with a stray dog problem. Foreman Salvador Gonzalez will assist Mr. Louviere.

Councilman Frank Boura wished everyone a Merry Christmas and Happy New Years.

Town Attorney Mitchell Theriot thanked the Mayor, Council, Police Department, and Police Clerks for assisting him during Court and as magistrate for the Town. Attorney Theriot also thanked everyone for their support during his recent election to the Court of Appeals.

Town Attorney Theriot will conduct the inauguration ceremony.

Councilman David Adams wished everyone Merry Christmas.
