Mayor Joey Bouziga informed the Council the Krewe of Athena and Krewe of Atlantis parades went very well, the Krewe of Nereids went well except for a problem with the parade captain and fire trucks, and the Krewe of Neptune was very disappointing with many complaints received regarding the conduct of riders.
