The Mayor and Council of the Town of Golden Meadow met for their regular rescheduled meeting on Monday, March 25, 2013 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded approving the minutes from the previous meeting held on Monday, March 4, 2013. The Council unanimously approved the motion as presented.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Chief Reggie Pitre introduced Mark Hutchinson representing Blue Line Solutions, LLC. Mr. Mark Hutchinson conducted a presentation regarding portable photo laser speed enforcement system and a photo speed enforcement mobile trailer. Mayor Joey Bouziga and the Council briefly discussed the matter. Mayor Joey Bouziga recommended Chief Reggie Pitre, Councilman David Adams, and Councilman Willis Toups to a committee to review the portable photo-laser speed enforcement system and the manned photo speed enforcement mobile trailer. Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded adopting Resolution No. 1545 appointing Chief Reggie Pitre, Councilman David Adams, and Councilman Jody Cheramie to a committee to review the portable photo-laser speed enforcement system and the manned photo speed enforcement mobile trailer. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a quote in the amount of \$3167.00 from Dubois Nursery for the purchase and delivery of six cement table sets. Mayor Joey Bouziga stated he would request assistance from the Lafourche Parish Recreation District No. 3.

Councilman Lindberg Lorraine informed the Mayor and Council Sewer Phase III was progressing well.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a demolition permit for Ms. Alice Boudreaux located at 107 Pelican Lane. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed Engineer John Plaisance was unable to attend this meeting to present a project update. Councilman Lindberg Lorraine presented an update on the Sewer Phase III Project. Joshua Combs representing the State of Louisiana contacted the office last week and informed us FEMA has sent written authorization for additional funding of Seawall Phase II. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Resolution No. 1546 awarding the construction contract for Seawall Phase II to the lowest bidder Circle, LLC in the amount of \$1,797, 139.00.The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Willis Toups seconded approving Ordinance No. 468 declaring the old Town Hall surplus and approving the sale of the old Town Hall at a minimum price of \$123,000.00. The Council unanimously approved the motion as presented.

Councilman Willis Toups and Councilman Jody Cheramie seconded approving Resolution No. 1547 adopting the 2012 Compliance Questionnaire. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Willis Toups approving the month of April Fair Housing Month. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Willis Toups seconded approving the Town Clerk advertise requesting professional engineering service proposals for the Golden Meadow Town Hall Improvement Project. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council there have been problems with people renting the Oakridge Park Pavilion and not having security during events where alcohol and/or music are involved. Mayor Joey Bouziga requested a public hearing be scheduled in order to discuss a proposed ordinance regarding the pavilion rental. Councilman Priscilla Mounic presented a motion and Councilman David Adams seconded approving advertisement of a public hearing to discuss the Oakridge Park Pavilion Rental Agreement. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested audience comments.

Mr. John Bellanger and Mr. Robert Lee presented questions regarding the manned photo speed enforcement mobile trailer and portable laser photo radar.

With no further business to discuss, Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving this meeting adjourns at 7:50 P.M. The Council unanimously approved the motion as presented.
