- Steve and Nancy Lee Cheramie 128 Meadow Lane Ms. Nancy Lee informed the Mayor and Council she is in the process of tearing the shed down.

- Sewer Phase III continues to progress.
- Sewer Phase IV is in the right of way stages.

- Seawall Phase II FEMA has approved additional funding and we are waiting approval from the State.
- Seawall Phase III is in the planning stages.
- Seawall Phase I is in the planning stages.
- Oakridge Park Waterlines Phase I and Phase II have been completed.
- Oakridge Park Waterlines Phase III has been submitted for funding.
- Frank's Supermarket Turning Lane has been awarded funding and is waiting for the Bond Commissioners approval.
- Fueling System funding was approved and a meeting will take place on Wednesday.
- Basketball Pavilion is waiting on approval from the Lafourche Parish Government.
- Town Hall Improvements (Maintenance Building) is being advertised for engineers.
- Street Resurfacing Project Phase III remains the same.

Councilman Willis Toups requested adding Department of Motor Vehicles to the agenda. Mayor Joey Bouziga requested audience comments. No audience comments were presented. Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving Councilman Willis Toups adds the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Councilman Willis Toups informed the Mayor and Council he was asked by Mrs. Sally Orgeron from the Department of Motor Vehicle if we could have someone control parking during court. Mayor Joey Bouziga stated during court the parking area is very congested, but once Lafourche Parish awards the contract to pave Jervis Drive parking will be improved.
