The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, April 15, 2013 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving the minutes from the previous meeting held on Monday, April 1,, 2013. The Council unanimously approved the motion as presented.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and John Plaisance led everyone in prayer.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving Chief Reggie Pitre advertise for part-time police officers and reserve officers. The Council unanimously approved the motion as presented.

Chief Reggie Pitre requested adding speed enforcement trailer to the agenda. Mayor Joey Bouziga requested audience comments. No audience comments were presented. Councilman Willis Toups presented a motion and Councilman David Adams seconded approving Chief Reggie Pitre adds the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Chief Reggie Pitre discussed the speed enforcement trailer discussed at a previous meeting. Chief Pitre spoke with different police departments regarding ordinances and resolutions necessary to place the trailer into operation. Mayor Joey Bouziga suggested Chief Pitre obtain any paperwork regarding this and let Attorney Bryce Autin review the paperwork and present a report. Councilman Willis Toups presented a motion and Councilman David Adams seconded approving Attorney Bryce Autin review any paperwork the Chief will present to him regarding the trailer. The Council unanimously approved the motion as presented.

Councilman Willis Toups requested adding a trash pickup complaint to the agenda. Mayor Bouziga requested audience comments. No audience comments were presented. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded

approving Councilman Willis Toups adds the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Councilman Willis Toups informed the Mayor and Council a pile of trash was placed in front of LA 1 across from Bob's Lane. Councilman Willis Toups stated that he had spoke to the trash pickup collection and was told they could not pick up such a large pile and that the contractor or owner of this old torn down boat is responsible for the pickup. Mayor Joey Bouziga stated he would contact the owner to discuss this matter.

No Building Permits or Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the clean-up report as follows:

- A complaint was received regarding tall grass and a broken fence on property located on Pershing Street owned by Jason LeBlanc. Councilman Priscilla Mounic presented a motion and Councilman David Adams seconded approving a clean-up letter be sent to Jason LeBlanc. The Council unanimously approved the motion as presented.
- A complaint was received regarding tall grass on property located on Nicole Lane. Councilman David Adams presented a motion and Councilman Willis Toups seconded approving a clean-up letter be sent to the property owner. The Council unanimously approved the motion as presented.

Mayor Bouziga presented the dangerous building permits as follows:

- Louis Adam Griffin 143 Griffin Lane has had no improvements.
 Councilman David Adams presented a motion and Lindberg Lorraine seconded approving a letter be sent to report to the Mayor and the Council at the meeting on May 6, 2013 at 7:00 P.M.
- Lloyd Ledet 133 Meadow Lane research has been conducted and the correct property owner is Adval. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a letter to be sent to the property owner.
- Nancy and Steve Cheramie 128 Meadow Lane . Mayor reported shed is still standing.

Engineer John Plaisance presented the project reports as follows:

- Sewer Phase III continues to progress and possible hook-ups could begin in May.
- Sewer Phase IV is in the right of way stages
- Seawall Phase II got paperwork for bids and constructing should begin in
- Seawall Phase III is in planning stages.
- Seawall Phase I is in the planning stages.
- Oakridge Park Waterlines Phase I & Phase II have been completed
- Oakridge Park Waterlines Phase III has been submitted for funding
- Frank's Supermarket Turning Lane has been awarded funding and is

waiting for the Bond Commissioners approval.

- Fueling System was approved and waiting on what took place at a meeting held on Wednesday.
- Basketball Pavilion Lafourche Parish Government has discussed extra funding in the amount of \$ 100,000.00. Councilman Priscilla Mounic presented and Councilman Willis Toups seconded approving Resolution No. 1551 be approved to consider a supplement appropriation from the Lafourche Parish Government for the extra \$ 100,000.00. The Council unanimously approved the motion as presented.
- Town Hall Improvements (Maintenance Building) is being advertised for engineers qualifications.
- Street Resurfacing Project Phase III Mayor Joey Bouziga stated Barriere Construction is conducting repairs in Town and any complaints should be turned into him so they can be report to Barriere.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving a walk permit for the Blessing of the Fleet 2 Mile Fun Walk to be held on Saturday, April 20, 2013 at 9:00 A.M. Mayor Bouziga requested Chief Reggie Pitre have an officer present to assist with the walk. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Lindberg Lorraine seconded approving Resolution No. 1549 authorizing Mayor Joey Bouziga sign and enter into an amended Intergovernmental Cooperative Agreement between the Town and the Housing Authority of Lafourche regarding sewer right of ways. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving Resolution No. 1550 authorizing Mayor to sign and enter into an agreement between the Town and Lafourche Parish Water District No. 1 for the collection of sewer bills. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested adding recommendation from Public Hearing to select sewer for the submission of application funding FY2014-15 LCDBBG Program to the agenda. Mayor Joey Bozuiga requested audience comments. No audience comments were presented. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Mayor Joey Bozuiga adds the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga would like to make his recommendation to select sewer for the submission of application funding FY2104-15 LCDBG Program. Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving Resolution 1552 approving the Town submit an application to the LCDBG Program 2014-2015 for funding Sewer Phase V . The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving Mayor Joey Bouziga's recommendation from the Public Hearing regarding the Golden Meadow Pavilion Rental. Mayor Joey Bouziga recommended to no longer charge for security for alcohol/entertainment events. Mayor Bouziga stated an

application must be filled out in order to be placed on the calendar to avoid any errors or misunderstandings. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and seconded by Priscilla Mounic to call a Public Hearing on May 6, 2013 at 6:45 P.M. to obtain a views on an ordinance stating that it shall be unlawful for any person in any public place or in view of public, to be found in a state of nudity or partial nudity or in any indecent exposure of his or her person or below-waist undergarments, or be guilty or any indecent or lewd behavior. The Council unanimously approved the motion as presented.

Mayor Bouizga requested audience comments.

Robert Lee addressed the Mayor and the Council on concerns of Frank Boura who has a pond on his property and states it's an endangerment to children and this town. Mr. Lee states it's a hazard with alligators and mosquitoes. Frank Boura advised he's putting up a barbed wire fence. Mayor Joey Bouziga suggested Attorney Bryce Autin to look into this matter of the barbed wire fence and to see if this is sufficient. Mayor suggested passing an ordinance regarding this matter if it is not sufficient due to several complaints he has received on this matter.

With no further business to discuss, Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving this meeting adjourns at 7:25 P.M. The Council unanimously approved the motion as presented.
