The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on July 15, 2013 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving minutes from the previous meeting held on July 1, 2013.

Councilman Lindberg Lorraine Lorraine led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Willis Toups informed the Council the property near the old Two Sisters is in need of attention. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a clean-up letter be sent to the property owners. The Council unanimously approved the motion as presented.

No building permits or occupational license were presented for approval.

Mayor Joey Bouziga presented the clean-up report as follows:

- 141 Terrebonne Lane has not been cut or cleaned. Mayor Joey Bouziga

 property has passed. Town employees will cut and clean the property and
 invoice the property owners.

- Property located at the end of Rue Pouche Vide has a deadline of July 31, 2013.
- A complaint was received regarding tall grass at 519 North Bayou Drive.
 Councilman Jody Cheramie presented a motion and Councilman Priscilla

 owner. The Councilman unanimously approved the motion as presented.

After a brief discussion Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving quotes are acquired for the demolition of the dangerous building. The Council unanimously approved the motion as presented.
- Dangerous building on Pelican Lane researching owner.

Town Engineer John Plaisance presented the project up dates as follows:

- Sewer Phase III is basically complete. A walk through is being scheduled.
- Sewer Phase IV has right-of-way specialists preparing for signatures.
- Seawall Phase II is under construction.
- Seawall Phase III is funded and is in the planning stages.
- Seawall Phase I Repair Project is in planning stages.
- Oakridge Park Waterlines Phase I and Phase II are complete waiting on the contractor to complete landscaping.
- Oakridge Park Waterline Phase III will be advertised for construction.
- Frank's Supermarket Turnaround is waiting on Bonding Attorney approval.
- Fueling System is progressing.
- Basketball Pavilion funding approved by the Lafourche Parish Government and is in planning stages.
- Town of Golden Meadow Multi-purpose Building additions plans are being worked on by Duplantis Design Group.
- Street Resurfacing Project is waiting on the Parish contractor to return for repairs.

Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving Mardi Gras report be deferred until the next Council meeting. The Council unanimously approved the motion as presented.

Councilman Lindberg Lorraine presented a motion and Councilman Jody Cheramie seconded approving Thomas Rodrigue be deferred until the next Council meeting. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council after researching the zoning laws a bunk/boarding house is allowed in the Pierce Street area. After a brief discussion Councilman Jody Cheramie presented a motion and Councilman Priscilla Mounic seconded approving a request be sent to the building inspector conduct an inspection to see if the property is adequately equipped to be a bunk/boarding house. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie presented a motion and Councilman Priscilla Mounic seconded approving Resolution No. 1570 authorizing Mayor Joey Bouziga execute an agreement with Bourgeois Bennett to conduct the 2013 Audit. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested adding two clean-up complaints, the subdivision of property for Shane Rogers, and District J Meeting to the agenda. No audience comments were presented. Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded approving the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented a clean-up complaint on 103 Verret Street. Councilman Willis Toups presented a motion and Councilman Lindberg Lorraine seconded approving a clean-up letter be sent to the property owners. The Council unanimously approved the motion as presented.
