The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving Resolution No. 1587 in support of submitting a request for funding from the Louisiana Government Assistance Program (LGAP). The council unanimously approved the motion as presented.

Mayor Joey Bouziga requested audience comments.

Mr. Greg Terry presented Councilman Priscilla Mounic with information regarding a skate board park. Councilman Priscilla Mounic thanked Mr. Greg Terry.
