Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving the minutes from the previous meeting held on Monday, July 21, 2014. The Council unanimously approved the motion as presented.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Mayor Joey Bouziga informed the Council, no building permits were presented for approval.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving an Occupational License for Kiley's Kreations located at 129 Dursette St. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the clean up reports as follows:

- Louis Adam Griffin -143 Griffin Lane was sent a cleanup letter. The deadline to clean-up is August 13, 2014.
- Harris Kief Estate/Genevieve Elliot property off of Cliff's Lane was sent a letter and the deadline was August 4, 2014. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving if it is not cut the town crew is to cut the grass and the property owner will be billed. The Council unanimously approved the motion as presented.
- Charles Parra property located on Chouest Lane was sent a clean-up letter on July 24, 2014. The deadline to clean-up is August 13, 2014. Engineer John Plaisance presented the project report as follows:

- Sewer North Plant Upgrades we are processing paperwork
- Sewer Phase IV Acquiring right-of-ways
- Sewer Phase V—waiting on funding
- Seawall Phase I Repairs waiting on contractor
- Seawall Phase II still waiting
- Seawall Phase Ill-waiting on additional funding
- Fueling System Fence is scheduled to be installed
- Basketball Pavilion is complete except for cleaning around the project.
- Town Hall Improvements Project Bids for construction are delayed due to the lowest bidder having conflict with contractor and ethics board will review the plans for Canopy for fuel tanks — Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving John Plaisance to work up a grant in the amount of \$35,000.00 for canopy for fuel tanks. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving Mayor Joey Bouziga move up on the agenda to honor South Lafourche 12U All Star Baseball All Star World Series Champions. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga and Council members presented members of the South Lafourche 12U All Star Baseball All Star World Series Champions with certificates on their winning.

Attorney Bryce Autin presented a legal update as follows:

- Sewer Ordinance Attorney Bryce Autin will have more to report at the meeting due to more that needs to be revised
- Unpaid Taxes & Clean-ups are in the process of being taken over by LAMATS.
- No update on unpaid sewer bills

Chief Reggie Pitre presented the Mayor and each Councilman with a pay comparison for police officers. After a brief discussion Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the new pay scale for police officers. The pay for a new hire who is not post certify will be \$12.80 with an overtime rate of \$19.20 and an officer who is

post certify with certain qualifications approved by Chief Reggie Pitre will be \$ 15.00 with an overtime rate of \$ 22.50. Officer Christopher Pitre will also have a rate increase to \$ 15.50 with an overtime rate of \$ 23.25. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving to adopt the ordinance discussed at the public hearing in reference to property owned by Town adjacent to and south of TK'S Sports Bar and generally measuring 17.78' along Alex Plaisance Blvd. x depth of 400' is surplus and not needed for public purpose. This property is valued at less than \$ 100,000 and will be exchanged for a parcel of property generally measuring 48' x 215' adjacent to Town's existing sewer treatment facility for the purpose of expanding Town's sewer treatment facility. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Willis Toups seconded approving to adopt the ordinance discussed at the public hearing in reference to property measuring roughly 19,500 square feet owned by Town east of the Town Hall and DMV Building and on Malgum Lane is surplus and not needed for public purpose. The property is valued at less than \$100,000 and will be exchanged for a parcel of property generally measuring 32.58' on Alex Plaisance Blvd. adjacent to Town Hall for the purpose of potential future expansion of Town facilities. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a tall grass and clean -up letter be sent to the property owner Estate of Genevieve Dantin located at 2303 North Bayou Drive. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving Knights of Columbus Can Shake to be held on August 16, 2014 from 7:00 A.M. to 1:00 P.M. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga reminded the Council about National Night Against Crime on Tuesday August 5, 2014 at 6:00 P.M. at Town Hall.
