The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, October 6, 2014 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving the minutes from the previous meeting held on September 15, 2014. The Council unanimously approved the motion as presented.

No building permits were submitted for approval.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving an Occupational License for Gulf American Wire Rope located at 1901 South Alex Plaisance Blvd. owner Jed LeBlanc. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the clean-up report as follows:

Mayor Joey Bouziga presented the dangerous building report as follows:

- Dinah Stallings 508 South Bayou Drive has been sent a letter to appear from the Town Attorney.
- Natilus Alario, Jr. 713-A North Bayou Drive has demolished the dangerous building, but the debris remains on the ground. Councilman Priscilla Mounic presented a motion and Councilman Lindberg Lorraine seconded approving a clean-up letter be sent to the property owner.

Mayor Joey Bouziga with the assistance of Engineer John Plaisance presented the project report as follows:

- Sewer North Plant Upgrades Engineer John Plaisance is working with Stat planning the upgrades.
- Sewer Phase IV contractor continues to acquire rights-of-ways.
- Sewer Phase V waiting on funding approval.
- Seawall Phase II complete with the retainage due to the contractor upon Clerk of Court recording.
- Seawall Phase I Repairs continue in from of Chine's Net Shop.
- Seawall Phase III is in the planning stages. Engineer John Plaisance met with Crosby Dry Dock to discuss plans.
- Fuel System Canopy is in the planning stages.
- Town Hall Improvements Project Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving M & H Buildings as the low bidders due to ethics issues with contractors. Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded adopting Resolution No. 1612 authorizing Mayor Joey Bouziga execute required documents required for the "Golden Meadow Community Center and Town Hall," funded under the Hurricanes Gustav/Ike CDBG Parish-Implemented Recovery Program. The Council unanimously approved the motion as presented. Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded adopting Resolution No. 1613 authorizing the commitment of Town of Golden Meadow's funds to the "Golden Meadow Community Center and Town Hall," funded under the hurricanes Gustav/Ike CDBG Parish-Implemented Recovery Program and certifying that the "urgent need" national policy objective is being met. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the Attorney's Report due to Attorney Bryce Autin's absence as follows:

The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a Can Shake Application for the Knights of Columbus on October 18, 2014 from 7:00 A.M. to 1:00 P.M. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving a Loud Music Permit for TK'S Sports Bar on Friday, October 31, 2014 from 7:00 P.M. to 12:00 A.M. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman David Adams seconded approving a parade permit for the Krewe of Athena to parade through the Town of Golden Meadow on Friday, February 13, 2015. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded adopting Resolution No. 1614 that the Town of Golden Meadow supports the passage of both Constitutional Amendment 3 and Constitutional Amendment 10 on November 4, 2014 as both constitutional amendments will provide valuable tools for municipalities and parishes to address the blighted property issues throughout the state in order to protect the health, safety and welfare of their citizens. The Council unanimously approved the motion as presented.
