Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting held on Monday, October 6, 2014 with a change of correction for loud music permit For T.K.S Bar from 7:00 P.M. to midnight not 2:00 A.M. The Council unanimously approved the motion as presented.

- Sewer North Plant Upgrade Engineer John Plaisance is working with Stat planning the upgrades and permission from state to proceed
- Sewer Phase IV contractor continues to acquire right-of-ways
- Sewer Phase V waiting on funding approval
- Seawall Phase II substantial completed and waiting on final payment
- Seawall Phase I Repairs continues in front of Chine's Net Shop
- Seawall Phase III Repairs is in the planning stages. Engineer John Plaisance met with property owner for further negotiating
- Fuel System Canopy is in the planning stages and waiting for more info
- Town Hall Improvements Project waiting on contractor
- Town Hall Turn Around State approved funding for \$ 120,000.00 for the turnaround project
- Capital Outlay Grant Application Councilman Jody Cheramie presented a
  motion and Councilman Lindberg Lorraine seconded approving a resolution
  authorizing Mayor Joey Bouziga to execute Capital Outlay Grant Application
  to replace the lift station behind the project. The Council unanimously
  approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Lindberg Lorraine seconded approving a parade permit for the Krewe of Nerieds to roll on Sunday, February 15, 2015. The Council unanimously approved the motion as presented.

Mr. Anthony Lewis candidate for Lafourche Parish Judge addressed the Mayor and Council presenting his qualifications as a candidate.

Councilman Willis Toups addressed the Mayor and Council on work done by a contractor on Armand St. The grass in the ditch needs to be cut and will be cut by the town crew. A brief discussion took place on the work being done by the water district in some streets. The repairs need to be completed on the black top as it was before the job was started. Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving Attorney Bryce Autin send a letter to Lafourche Parish Water district to make the necessary repairs. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga deferred the bids for the fuel tanks to the next meeting due to it not being on the agenda.

With no further business to discuss Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded adjourning this meeting at 7:23 P.M. The Council unanimously approved the motion as presented.
