The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, July 6, 2015 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

A division of property was requested by Mary Rotolo located in Section 6, T20S, and R22E. Said tract was recently divided into two (2) lots and is recorded in the Lafourche Parish Clerk under entry # 1200049 and is now being revised to be divided into three (3) lots. Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded approving a Planning and Zoning Commission meeting on Monday, August 3, 2015 at 6:30 P.M. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council Attorney Bryce Autin is in the process of sending Mr. Shane Rogers a letter regarding his failure to apply for a building permit.

No Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the clean-up report as follows:

- Gail Cheramie 130 Terrebonne Lane was cut but needs additional work. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a contractor be hired to complete the trimming of her property. The Council unanimously approved the motion as presented.
- Edward Diaz property located off South Bayou Drive was sent a clean-up letter which was returned unclaimed. Councilman David Adams presented a motion and Councilman Jody Cheramie

seconded approving a contractor be hired to cut and clean the property. The Council unanimously approved the motion as presented.

- Ashley Adams 505-C North Bayou Drive was sent a clean-up letter June 17, 2015.
- A complaint was received on property owned by Louis Griffin.
 Councilman David Adams presented a motion and Councilman
 Willis Toups seconded approving a clean-up letter be sent. The

Mayor Joey Bouziga presented the dangerous building report as follows:

 Mr. Harry Cheramie 2621 – A North Bayou Drive was sent a dangerous building letter. Mayor Joey Bouziga informed the Council Mr. Cheramie contacted the Town Hall and advised he has a contractor evaluating the dangerous building on Wednesday and he will report then.

Mr. Curtis Bruce informed the Council he received a letter regarding an abandoned vehicle which he doesn't own. Mayor Joey Bouziga informed Mr. Curtis Bruce the letter will be forwarded to the appropriate person.

Mayor Joey Bouziga informed the Council the Town Engineer is absent and he will present the status of a few of the projects as follows:

- Skateboard Park will be discussed at a special meeting on Wednesday, July 8, 2015 from 6:00 P.M. to 8:00 P.M.
- Town Hall Improvements foundation will be poured on Friday, July 10, 2015.

Mayor Joey Bouziga informed the Council the Town Attorney is absent.

Mayor Joey Bouziga presented Ordinance 485 regarding the use of golf carts through the Town of Golden Meadow. After a brief discussion Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving Ordinance 485 with the following changes: add scooters and lawn mowers, add children under 4 should be secured in a child seat (car seat or booster), instead of a title it should read proof of ownership (golf carts do not have titles), and the time needs to change from dawn to 9:00 P.M. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented Ordinance 486 regarding the digging of dirt pits through the Town of Golden Meadow. After a brief discussion Councilman Priscilla Mounic presented a motion and Councilman David Adams second approving Ordinance to include preventing dirt pits or ponds through the Town of Golden Meadow. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving the lowest quote from SBL Construction, LLC in the amount of \$21,400.00. The Council unanimously approved the motion as presented. Mayor Joey Bouziga informed the owner of SBL, Construction, LLC, the Town Attorney will prepare a contract for the job.

Mayor Joey Bouziga informed the Council due to a recent compliant a letter was sent to Asst. Fire Chief Kully Griffin regarding the speed of emergency vehicles. A lengthy discussion took place.

Councilman Priscilla Mounic presented a motion and Councilman Willis Toups seconded approving Resolution No. 1641 appointing Mayor Joey Bouziga represent the Town of Golden Meadow on the LCDA Board. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council he received a complaint of a suspected bunkhouse at a building owned by Black & Hornsby Property, LLC located at 2124 South Alex Plaisance Blvd. After a brief discussion Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a letter be sent to the property owners requesting they describe what their property and building are being used for. The Council unanimously approved the motion as presented.

Councilman David Adams informed the Mayor and Council of problems with cracks in the pavement at the end of Norman Street. Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving a letter be sent to Parish President Charlotte Randolph and Parish Councilman Daniel Lorraine. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman David Adams seconded approving the Bush hog be declared surplus equipment and advertised for sale. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman David Adams David Adams seconded approving the Little Eagle electrical drainage pump be declared surplus junk. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving the 2011 Ford Crown Victoria Police Interceptor be declared surplus equipment and advertised for sale for the listed value. The Council unanimously approved the motion as presented.
