The Mayor and Council of the Town of Golden Meadow met for their regular reschedule meeting on Tuesday, September 8, 2015 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Willis Toups presented a motion and Councilman Lindberg Lorraine seconded approving the minutes from the Town of Golden Meadow's meeting held on August 17, 2015. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Willis Toups seconded approving an Occupational license for Jack of All Trades AJF, Inc. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the clean-up report as follows:

- Gloria Bouzigard 112 Delgrandile Lane property owner continues to clean her property.
- Louis Adam Griffin C/O Patrick Wayne Hooks 143 Griffin Lane was bulldozed, but the grass remains taller than permissible by Town Ordinance. - John Parker South Bayou Drive property owner has secured the building but the property remains in violation of Town Ordinance regarding junk and tall grass. The Town Clerk informed the Mayor and Council the letter sent to Mr. John Parker was returned. Councilman David Adams presented a motion and Councilman David Adams seconded approving the property be advertised notifying the property owner the property is in need of attention. The Council unanimously approved the motion as presented.
- Edward T Diaz property 1606 South Bayou Drive was cut by town employees and will be billed accordingly.
- Callais/Landry property located on Pelican Lane received a tall grass complaint. After a brief discussion, Councilman David Adams presented a

Mayor Joey Bouziga informed the Council the dangerous building owned by Mr. Harry Cheramie located at 2621 North Bayou Drive has been repaired. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the repairs to the building and removing this dangerous building from the agenda. The Council unanimously approved the motion as presented. Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving a "Thank You" letter be sent to Mr. Harry Cheramie for repairing his dangerous building. The Council unanimously approved the motion as presented.

Chief Reggie Pitre informed the Mayor and Council the Public Nuisance/Abandoned Vehicle Project continues but has slowed down. Chief Reggie Pitre informed the Mayor and Council the Police Department is working on removing abandoned boats and boat trailers.

Mayor Joey Bouziga informed the Council Attorney Bryce Autin and Engineer John Plaisance were absent from the meeting.

Town Clerk, Jamie Liner informed the Mayor and Council Attorney Bryce Autin sent a letter to Black and Hornsby Properties, LLC regarding a report a complaint received stating they were running a Boarding House at 2124 S. Alex Plaisance Blvd. Black and Hornsby, LLC emailed a letter to inform the Town he has the house leased to one family. With no other complaints received on this property, Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded accepting the letter from the property owner and remove Black and Hornsby, LLC from the agenda. The Council unanimously approved the motion as presented.

Town Clerk, Jamie Liner informed the Mayor and Council Attorney Bryce Autin was in the process of sending John Delatte a letter regarding a complaint he is running a Boarding House.

Town Clerk, Jamie Liner informed the Mayor and Council if there were no changes to the fine schedule a Public Hearing could be scheduled to propose the amended Ordinance. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a Public Hearing on Monday, October 5, 2015 at 6:30 at the Town Hall to discuss the proposed Ordinance to amend the Fine Schedule. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a resolution declaring the 2011 Ford Crown Victoria police interceptor and the New Holland Tractor surplus equipment and authorizing Mayor Joey Bouziga sign all documents involved in sending the items to the state auction.
