The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, September 21, 2015 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting held on Tuesday, September 8, 2015. The Council unanimously approved the motion as presented.

- Sewer Phase IV continues in the right-of-way phases.
- Sewer Phase V Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded approved adopting a Resolution for Residential Antidisplacement and Relocation Assistance Plan and authorizing in connection with the FY 2015 Louisiana Community Development Block Grant for Golden Meadow Phase V Community Sewerage System Preliminary Engineering Report. The Council unanimously approved the motion as presented.
- Sewer Phase VI South Central Planning is surveying the area.
- Seawall Phase III will be taking bids on Thursday.
- Town Hall Turnaround approval to start advertising.
- Capital Outlay Grant for Lift Station Upgrades waiting on paperwork from the state. Mayor Bouziga stated the paperwork has been signed.
- Skate Board Park waiting on submission plans.
- Town Hall Improvements Project Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded approved adopting a Resolution for the contract administration policy and records management policy for implementation in its Hurricane Gustav/Ike CDBG Disaster

Recovery Program and authorizing the Mayor to sign any and all documents required to meet these regulations for the administrations of the program. The Council unanimously approved the motion as presented.

- Water Enrichment Grant was submitted for funding and new water lines will be installed in 2016.
- Pool Repairs waiting on contractor to begin repairs.
- Cleaning Drainage Reservoir several projects were discussed and will be presented at the next meeting.

Attorney Bryce Autin presented the legal reports:

- Unpaid Sewer still progressing
- Fine Schedule a Public Hearing to adopt an Ordinance will be held on October 5, 2015
- John Delatte 1102 South Bayou Drive was sent a letter to appear at this
 meeting or the next meeting on October 5, 2015. Mr. Delatte was not

- Information on public auctions Attorney Bryce Autin discussed he had spoken to a representative at the state public auction. After a brief discussion he stated due to the cost of getting the equipment there, on-line auction is available and that is his recommendation. The Council unanimously approved the motion as presented.
- Recreational Vehicles Attorney Bryce Autin has reviewed the Lafourche Parish Ordinance on recreational vehicles and will present more information at the next meeting. Until then all recreational vehicle permits are to be put on hold until further notice.

Mayor Joey Bouziga informed the Council the 2011 Crown Vic and the New Holland tractor will not be re-advertised but will be advertised on the on-line public auction as stated previously in the meeting.

Mayor Joey Bouziga informed the Council a complaint was received regarding several business advertisement signs that are not in compliance with the town ordinance. Several letters were sent out to local businesses and they will need variances for the signs or remove them. This is to be left on the agenda to be discussed at the next meeting on October 5, 2015.

Mayor Joey Bouziga presented a parade permit for the Krewe of Athena to parade on Friday, February 5, 2016 at 7:00 P.M. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the parade permit for the Krewe of Athena. The Council unanimously approved the motion as presented.
