The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, November 2, 2015 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Jody Cheramie presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting held on Monday, October 19, 2015. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council Shane Roger's building permit for a recreational vehicle will remain on hold until Attorney Bryce Autin can update the Council on the laws governing recreational vehicles according to FEMA.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving an Occupational License for Entergy Louisiana, LLC. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the Public Nuisance/Abandoned Vehicles report:

 Brian Eymard – Mr. Eymard addressed the Mayor and the Council on his public nusiance vehicle. After a brief discussion took place Councilman Jody Cheramie presented a motion and Councilman David Adams seconded approving to grant Mr. Eymard a 3 month extension. The Council unanimously approved the motion as presented.

Town Engineer John Plaisance presented the project status report as follows:

- North Sewer Plant Upgrades remains in the planning stages and are ready to move forward
- Sewer Phase IV remains in the right-of-way stages.
- Sewer Phase V remains in the right- of- way stages.
- Sewer Phase VI is in the process of applying for funding
- Seawall Phase III were received over budget.
- Town Hall Turnaround is waiting on paperwork from the state authorizing the project to begin.
- Skate Board Park has a bid date scheduled for Dec. 10.
- Town Hall Improvements Project is almost complete. Mayor Joey Bouziga informed the Council a walk through has discovered some issues that need to be address by the contractor and change order # 2 needed to be approved to put catch basins and additional cement at a cost of \$ 9763.00. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving change order # 2 to install catch basins and additional cement at a cost of \$ 9763.00. The Council unanimously approved the motion as presented.
- Water Enrichment Grant has been submitted for funding and waiting on approval.
- Pool Repairs are waiting on the contractor to begin.
- Capital Outlay Projects 2016 4 projects have been submitted.

Mayor Joey Bouziga requested audience comments.

Mr. Uyless and Mrs. Marcy Boudreaux addressed the Mayor and Council on several issues presented that need attention mainly concerning property clean-up. After a lengthy discussion Attorney Bryce Autin will have an update at the next meeting on this matter.
