The Mayor and Council for the Town of Golden Meadow met for their regular scheduled meeting on Monday, February 15, 2016 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Those present were: Mayor Joey Bouziga

Mayor Joey Bouziga called this meeting to order at 7:00 P. M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded approving the minutes to the previous meeting held on February 1, 2016. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council the building permit for Shane Rogers to place a recreational vehicle on his property is still on hold.

Mayor Joey Bouziga informed the Council no Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the clean-up report as follows:

Estate of Victor Boudreaux/Alice Boudreaux – 136 Pelican Lane has not been cut.
Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the Town employees cut the grass at the expense of the property owner. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the dangerous building report as follows:

• Lincoln Martin – 115 Mrs. Thomas Pitre Lane – was issued a 60 day extension with a deadline of March 21, 2016.

Mayor Joey Bouziga presented the Public Nuisance/Abandoned Vehicle report as follows:

 A complaint was received regarding an abandoned truck and golf cart on property owned by the Estate of Jerry Verdin, Jr. Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving the vehicles be tagged and a letter be sent to the family of Mr. Verdin. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented an update on a few of the projects in town as follows:

• Seawall Phase III – A pre-construction conference took place last week.

- Skate Board Park Mayor explained he is gathering quotes for the construction of a bathroom, upgrades to the tennis courts, and pool repairs in Oakridge Park and the remaining funds from these projects should be enough to complete the skate board park.
- Pool Repairs waiting on an estimate from AC Cross.
- Drainage Reservoir has been cleared by an excavator provided by the Lafourche Parish Government.

Mayor Joey Bouziga informed the Council the legal report will be delayed due to the absence of

Attorney Bryce Autin.

Mayor Joey Bouziga informed the Council the old Town Hall was appraised and should be placed for

sale. Mayor Joey Bouziga informed the Council he will turn this over to the Town Attorney.

Mayor Joey Bouziga informed the Council repairs to the civil defense building are complete.

Mayor Joey Bouziga informed the Council repairs to the flood gate in Oakridge Park continue.

Mayor Joey Bouziga informed the Council Mardi Gras went well except several complaints received regarding the Krewe of Neptune. After a brief discussion, the Mayor and Chief agreed to speak to the Krewe again and if this parade is not cleaned-up their parade permit will be denied. Mayor Joey Bouziga and the Council also thanked the town employees for cleaning the Town after each parade.

Councilman David Adams presented a motion and Councilman Willis Toups seconded approving the removal of a light across from Frank's Supermarket and placing it at the end of Rosa Drive.

Councilman David Adams informed the Council engineers from Entergy went out to the end of Louviere Lane to determine if a power pole with a street light could be installed and will provide an estimate to the Town.

Mayor Joey Bouziga informed the Council the costs for the construction of a bathroom near the Dixie Youth baseball field is \$69,336.15 and the installation of lights and refurbishing the tennis courts is \$41,072.26 for a total of \$110,408.41.

Lafourche Parish Councilman Daniel Lorraine reviewed all the projects in the Town of Golden Meadow paid for by Lafourche Parish the past few years.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving the Town Clerk invest funds for General Fund and the Sales Tax Fund. The Council unanimously approved the motion as presented.

Mr. Greg Terry informed the Mayor and Council he did contact the Toney Hawk Organization regarding additional funding for the Skate Board Park. A report will be presented at the next meeting.

Mayor Joey Bouzgia requested audience comments.
