The Mayor and Council of the Town of Golden Meadow met for their regular rescheduled meeting on Monday, June 27, 2016 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded approving the minutes from the previous meeting held on Monday, June 6, 2016. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council Shane Roger's building permit application remains on hold until a new recreational vehicle ordinance can be revised.

Mayor Bouziga informed the Council a building permit was applied for by Interstate Transport & Broadband, LLC. A discussion took place on this permit and Engineer John Plaisance gave a brief explanation to the Mayor and Councilman on his concerns of this tower to be placed on Fred St. and he thinks it would be a safety hazard. Mayor Joey Bouziga recommended that the permit should be rejected. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded upon the Mayor's recommendation that this permit application is to be rejected. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie presented a motion and Councilman Priscilla Mounic seconded approving an Occupational License for Off the Bone Meat Market located at 704 North Alex PLiasance Blvd. owner Rickey Vaughan, Jr. The Council unanimously approved the motion as presented.

Town Engineer John Plaisance presented the project status report as follows:

- North Sewer Plant Upgrades has been approved by DHH.
- Sewer Phase IV remains in the rights-of-way stage.
- Sewer Phase V remains in the rights-of-way stage.
- Sewer Phase VI remains in the rights-of-way stage.
- Economic Development Adminstration (EDA Grant) has been submitted for funding and looking good.
- Seawall Phase III has begun and a resolution is needed to approve a DRA checking account. Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving a resolution to approve a DRA checking account. The Council unanimously approved the motion as presented.
- Town Hall Turnaround is approved and waiting on paperwork to be sign by the Governor.
- Skate Board Park construction has begun
- 2014/2015 Community Water Enrichment Grant is ready to begin.
- 2015/2016 Community Water Enrichment Grant needs a resolution authorizing Mayor Joey Bouziga sign all documents regarding the 2015/2016 CWEF Grant. Councilman Priscilla Mounic presented a motion and Councilman Jody Cheramie seconded approving a resolution authorizing Mayor Joey Bouziga sign all documents regarding the 2015/2016 CWEF Grant. - 2015/2016 LGAP Grant for two sewer generators is waiting on approval from the state.
