## Town of Golden Meadow 107 Jervis Drive Golden Meadow, LA 70357

The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, March 20, 2017 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Those present were: Mayor Joey Bouziga Councilman Ashton Cheramie Councilman Jody Cheramie Councilman Laci Latiolais Councilman Lindberg Lorraine Councilman Willis Toups

Others attending were Trixie Allemand, Salvador Gonzalez, Sr., Ellis Guidry, Daniel Lorraine, Doc Louviere, Pat Louviere, Chief Reggie Pitre and John Plaisance.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Lindberg Lorraine presented a motion and Councilman Willis Toups seconded approving the minutes from the previous meeting held on Monday, March 6, 2017. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council there were no Building Permits presented.

Mayor Joey Bouziga informed the Council there were no Occupational Licenses presented.

Mayor Joey Bouziga presented the clean-up reports as follows:

- Chet Louivere A tall grass/clean-up complaint was received for property located at 153 Theriot St. Councilman Willis Toups presented a motion and Councilman Laci Latiolais seconded approving a tall grass/clean-up letter be sent. The Council unanimously approved the motion as presented.
- Ramsden Griffin A tall grass/clean-up complaint was received for property located at 156 Callais Lane. Councilman Willis Toups presented a motion and Councilman Lindberg Lorraine seconded approving a tall grass/ clean-up letter be sent. The Council unanimously approved the motion as presented.
- Alice Boudreaux A tall grass/clean-up complaint was received for property located at LA 1 Pelican Lane. Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving a tall grass/ clean-up letter be sent. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the dangerous building reports as follows:

- Edison Lee 154 Delgrandile Lane had a deadline to complete demolition as of March 6, 2017 and is now pass this deadline. Councilman Willis Toups presented a motion and Councilman Lindberg Lorraine seconded for Attorney Bryce Autin send a letter that all debris needed to be cleaned by the next meeting. The Council unanimously approved the motion as presented.
- Emile Guidry 196 and 200 Pierce St. The Building Inspector inspected the two mobile homes and both failed inspection. Mayor Bouziga informed the Council that he had spoken to Mr. Guidry and he is getting quotes on demolition and still have no update.

Town Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV- advertising for bids will take place about April.
- Sewer Phase V advertising for bids will take place in May
- Sewer Phase VI (EDA Sewer Grant) advertise for bids mid- summer.
- Seawall Phase III a letter will be sent by Bryce or John that the Town expects to have a straight bulkhead.
- Skateboard Park Councilman Willis Toups commended field workers on great work done in the park.
- 2014/2015 Community Water Enrichment Fund Grant Town Hall waterlineproject continues and progressing.
- 2015/2016 Community Water Enrichment Fund Grant still waiting.
- 2017/2018 LGAP Grant still waiting.
- Town Hall Turnaround still waiting.
- Capital Outlay Projects still waiting will have more information by June.

Mayor Joey Bouziga presented legal reports as follows:

 RV Revised Ordinance – A Public Hearing was held earlier on RV Revised Ordinance. Attorney Bryce Autin was absent but Mayor Joey Bouziga had spoken to Attorney Bryce Autin and he had no recommendation regarding a summons being written, that just a letter can be sent. Councilman Laci Latiolais would like to recommend adding to the new ordinance that all new campgrounds would need a washateria. Councilman Ashton Cheramie presented a motion and Councilman Willis Toups seconded approving to adopt the RV revised ordinance held at the Public Hearing. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council that Attorney Bryce Autin has drafted a contract authorizing Mayor Joey Bouziga to sign a contract for SBL contractor to begin work on the soccer field. Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded approving Mayor Joey Bouziga be authorized to sign the contract with SBL to begin work on the soccer field. The Council unanimously approved the motion as presented.

Mayor Joey Bouizga presented sealed bids for bulkhead supplies previously advertised. Mayor Bouziga opened two sealed bids. The first bid was submitted by Wilson Terry in the amount of \$ 5850.00 and the second bid submitted was by E & L Enterprise in the amount of \$ 5200.00. Councilman Willis Toups presented a motion and Councilman Lindberg Lorraine seconded awarding the bid to Wilson Terry in the amount of \$ 5850.00 for the bulkhead supplies. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving to adopt a resolution authorizing Mayor Joey Bouziga enter into and execute Cooperative Endeavor Agreement with SCPD for the implementation of the Louisiana State Uniform Construction Code. The Council unanimously approved the motion as presented.

Councilman Laci Latiolais reported she met with the director of the Leeville Cultural Festival who will be hosting an event on April 1, 2017 at Oakridge Park Pavilion. This event will attract lots of tourist and it was suggested that a barricade be put in place to partially closed parts of the park due to large crowds expected. Councilman Laci Latiolais presented a motion and Councilman Jody Cheramie seconded authorizing to work with the Chief and that a barricade be put in place to partially close the park and that it be accessible to be moved quickly in case an emergency should occur. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested audience comments.

Mr. Daniel Lorraine thanked everyone on the success of the skateboard park and complimented Mayor Joey Bouziga and past Councilman Priscilla Mounic on their accomplishments.

Councilman Jody Cheramie recommended updating the park picture.

With no further business to discuss Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded adjourning this meeting at 7:29 P.M. The Council unanimously approved the motion as presented.
