Mayor Joey Bouziga called this meeting to order at 10:30 A.M.

Mayor Joey Bouziga explained the purpose of the special meeting is to consider Resolution No. 1718 authorizing the Louisiana State Mineral and Energy Board to nominate Town property for state agency mineral lease.

Mayor Joey Bouziga presented Resolution No. 1718 to the Council. Councilman Jody Cheramie presented a motion and Councilman Willis Touts seconded approving Resolution No. 1718 authorizing the Louisiana State Mineral and Energy Board to nominate Town property for state agency mineral lease. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested adding Dangerous Building located on Palmetto Lane to the agenda. No comments or questions were presented in opposition of adding the aforesaid to the agenda. Councilman Willis Touts presented a motion and Councilman Jody Cheramie seconded approving Mayor Joey Bouziga add the dangerous building on Palmetto Lane to the agenda. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council he received a complaint regarding the dangerous situation being created by the abandoned house located at 114 Palmetto Lane. Councilman Lindberg Lorraine presented a motion and Councilman Willis Touts seconded approving the building inspector be contacted to perform an inspection of the dangerous building. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested adding Russell Drive to the agenda. No comments or questions were presented in opposition of adding the aforesaid to the agenda. Councilman Willis Touts presented a motion and Councilman Laci Latiolais seconded approving Mayor Joey Bouziga add Russell Drive to the agenda. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council it was brought to his attention that there was some washout or culvert problems at the front end of Russell Drive. Mayor Joey Bouziga informed the Council, he, Attorney Bryce Autin, and Engineer John Plaisance visited the sight and the problem is located just past the state right of way. There are 501' of culverts located at the front of Russell Drive. Mayor Joey Bouziga stated we have to research who installed these culvert because so far no records or maps have been discovered showing the Town installed them. Engineer John Plaisance informed the Mayor culverts are not actually needed at this location due to the way the property drains. Mayor Joey Bouziga stated everyone would like to help these residents resolve this situation, but this is a private street. Mayor Joey Bouziga stated we would continue to research this situation.
