The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, October 1, 2018 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called the meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting is adjourned.

Mr. John Plaisance led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Lindberg Lorraine presented a motion and Councilman Laci Latiolais seconded approving the minutes from the Council meetings held on September 17, 2018 and September 20, 2018. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented a Building Permit Application submitted by Sau Mo Yeung – 162 Wilfred Duet Street. The Planning and Zoning Commission met prior to this meeting to discuss a variance to allow a mobile home in an R-1 zone. Mr. McNeely Rome informed the Mayor and Council the Planning and Zoning Commission unanimously approved recommending to the Council the permit be approved. Councilman Jody Cheramie presented a motion and Councilman Lindberg Lorraine seconded approving the building permit application with the zoning change to an R-1 zone to allow for a mobile home to be at 162 Wilfred Duet Street, upon the unanimous recommendation of the Planning and Zoning Commission. The Council unanimously approved the motion as presented.

- Kibodaux Property 114 Meadow Lane Mayor Joey Bouziga stated the contractor who placed the lowest quote will honor his bid previously presented. The demolition will take place on Thursday, October 4, 2018. Ms. Tammy Kibodaux and Mr. Al Kibodaux have both been notified by letter.

Town Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV work continues and the change orders have been submitted to the State for approval.
- Sewer Phase V sewer connections are taking place.
- Sewer Phase VI (EDA Sewer Grant) we continue to seek matching funds.
- South Sewer Treatment Plant tanks are being monitored.
- Seawall Phase III A –Bids are being accepting on Tuesday.
- Seawall Phase IV Meeting with DOTD on October 16, 2018.

- 2015/2016 Community Water Enrichment Fund Grant/Doucet Drive No bids were received. The Town Attorney, Town Clerk, and I will meet to discuss acquiring quotes for the project.
- Upgrades to the North Sewer Treatment Plant waiting on paperwork from the State
- Town Hall Turning Lane Documents are being prepared to submit to the State for the lowest quote received. Mayor Joey Bouziga stated the State is requesting Amendment #2 to the original contract be executed. Councilman Ashton Cheramie presented a motion and Councilman Jody Cheramie seconded authorizing Mayor Joey Bouziga execute Amendment # 2 to the project contract. The Council unanimously approved the motion as presented.
- 2018/2019 LGAP Grant Application An application has been submitted tin the amount of #35,000.00 to repair and replace the sidewalk between Cliff's Lane and Callais Lane

Attorney Bryce Autin presented the legal report as follows:

- Working with LL & E to amend the contract for Oakridge Park due to the installation of a new sewer tank.
- Amendment to the collection agreement with American Municipal Services was explained. Councilman Laci Latiolais presented a motion and Councilman Ashton Cheramie seconded approving Attorney Bryce Autin draft an Ordinance to be presented to amend the collection agreement. The Council unanimously approved the motion as presented.

Chief Reggie Pitre police stats for the month of September were included in each Councilman's folder. Mayor Joey Bouziga stated if anyone had any questions regarding the stats, Chief Reggie Pitre could be contacted at the office.

Councilman Laci Latiolais presented a motion and Councilman Ashton Cheramie seconded approving the August Finance Report be deferred until the next meeting. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga received a Resolution in support of the garbage tax reinstatement. Each Councilman will received a copy of the resolution and it will be presented for a vote at the next Council meeting.

Mayor Jody Bouziga requested any other business to be discussed. With no other business to discuss, Councilman Jody Cheramie presented a motion and Councilman Laci Latiolais seconded approving this meeting adjourn at 7:17 P.M. The Council unanimously approved the motion as presented.
