The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, January 7, 2019 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called the meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting is adjourned.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Willis Toups presented a motion and Councilman Laci Latiolais seconded approving the minutes from the Council meeting held on December 17, 2018. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council no Building Permit Applications were submitted for approval.

Mayor Joey Bouziga requested adding an Occupational License for Rousse's Supermarket be added to the agenda. No comments or questions were presented in opposition of adding to the agenda. Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving the aforesaid to the agenda. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving an Occupational Licenses for the transition from Frank's Supermarket to Rousse's Supermarket. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the Clean-up report as follows:

• Al and Tammy Kibdoaux – 114 Meadow Lane has been cut and cleaned.

Mayor Joey Bouziga presented the Dangerous Building report as follows:

 Richard Greene- 2607 N. Bayou Drive. Mr. Richard Greene informed the Mayor and Council he is in the process of selling the dangerous building and property to Mr. Devin Dedon. Mr. Devin Dedon informed the Council he intends to purchase the property provided he can acquire a clear title to the property. Mr. Dedon stated once the property is purchased, he will need approximately two months to complete the demolition. • Al and Tammy Kibodaux – 114 Meadow Lane – Attorney is in the process of filing an affidavit allowing the Town to get reimbursed for the demolition and clean-ups.

Mayor Joey Bouziga presented two project updates as follows:

- Sewer Phase V Mayor Joey Bouziga stated as discussed in the Public Hearing he had two issues which need to be corrected. Mayor Joey Bouziga stated the Council requested J. Wayne Plaisance, Inc. place the contractor LA Contracting Enterprise, LLC on notice that a complaint was received from Jesus Felipe Alamilla Romero 133 Theriot Street regarding damage to their house during construction and Gerald Plaisance 154 Theriot Street whose waterline was broken on two occasions. Mayor Joey Bouziga stated all other issues that were brought to the Council's attention were resolved. Mrs. Martha Cazaubon informed the Mayor and Council she would follow-up with the J. Wayne Plaisance, Inc.
- Doucet Street Waterline Mayor Joey Bouziga informed the Council the agreement with the Lafourche Parish Water District has been executed and we are ready for construction. Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded authorizing Mayor Joey Bouziga execute any additional documents required for the Doucet Street Waterline. The Council unanimously approved the motion as presented.

Councilman Laci Latiolais presented a motion and Councilman Jody Cheramie seconded deferring the remainder of the project report due to the absence of the Town Engineer, John Plaisance. The Council unanimously approved the motion as presented.

Councilman Laci Latiolais presented a motion and Councilman Willis Toups seconded deferring the Attorney's legal report due to the absence of Attorney Bryce Autin. The Council unanimously approved the motion as presented.

Chief Reggie Pitre invoice from Lafourche Parish Sheriff's Office. Mayor Joey Bouziga stated he contacted Sheriff Craig Webre to discuss the invoice for the use of the Zeurcher System, Sheriff Craig Webre stated he would be in contract with Golden Meadow after January 1, 2019.

Chief Reggie Pitre requested the Council declare the 2012 Dodge Charger surplus and be placed on the GovDeals auction website. Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded declaring the 2012 Dodge Charger surplus and be placed on the GovDeals auction website. The Council unanimously approved the motion as presented.

Chief Reggie Pitre requested surplus equipment be deferred so that he can complete a list of items to be declared surplus items. Councilman Laci Latiolais presented a motion and Councilman Jody Cheramie seconded deferring surplus property. The Council unanimously approved the motion as presented.

Town Engineer John Plaisance entered the meeting as the Mayor and Council considered comments and opinions on the performance and implementation of the 2015 Community Sewerage Phase V. Mayor Joey Bouziga presented his two issues which need to be corrected. Mayor Joey Bouziga stated the Council requested J. Street had been resolved and LA Contracting Enterprise, LLC was put on notice regarding the issue at Jesus Felipe Alamilla Romero – 133 Theriot Street mid December.

Councilman Ashton Cheramie requested a street light be installed on Picciola Lane. Councilman Ashton Cheramie presented a motion and Councilman Jody Cheramie seconded approving the installation of a street light on Picciola Lane. The Council unanimously approved a motion as presented.

Engineer John Plaisance informed the Mayor and Council, J. Wayne Plaisance, Inc. was purchased by GIS. Engineer Plaisance stated the Town should not notice any changes. Town Engineer John Plaisance presented the remainder or the project report as follows:

- Sewer Phase IV continues. LA Contracting Enterprise, LLC is waiting on the correct pipe to bore under Ridgewood Blvd. Besides Ridgewood Blvd., Callais and a few small streets.
- Sewer Phase V was discussed earlier.
- Sewer Phase VI an application has been submitted the State of Louisiana Capital Outlay Program for matching funding. As of this time the Town has committed to paying \$325,000.00.
- Seawall Phase III we are working with GOHSEP to begin construction of Seawall Phase III-A.
- Seawall Phase IV we continue to work with DOTD to prepare a final application for funding.
- North Sewer Treatment Plant Upgrades documents have been submitted to the state for approval.
- LGAP an application has been submitted for the replacement of sidewalks between Cliff's Lane and Callais Lane.

Councilman Willis Toups presented a motion and Councilman Jody Cheramie seconded approving the Delta Regional Authority checking account be closed. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested audience comments.

Councilman Willis Toups asked Chief Reggie Pitre if there was any information on the theft of the Golden Meadow welcome sign. Chief Pitre stated there was evidence that was submitted to the crime lab and a reward was offered by Crime Stoppers. Councilman Willis Toups presented a motion and Councilman Laci Latiolais seconded approving the purchase of a new sign. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga stated there are kids running the streets at night and would like to see the curfew changed from 9:00 P.M. to 8:30 P.M. during daylight savings time. A brief discussion took place. Councilman Jody Cheramie presented a motion and Councilman Ashton Cheramie seconded calling for a Public Hearing to discuss the change in curfew on Tuesday, January 22, 2019. The Council unanimously approved the motion as presented.
