The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, September 21, 2020 at 7:00 P.M., at the LaSalette Center, Golden Meadow, LA 70357.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Mayor Joey Bouziga called the meeting to order at 7:00 P.M.

Councilman Willis Touts led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Mayor Joey Bouziga stated there were no Building Permit Applications or Occupational Licenses submitted for approval.

Town Engineer John Plaisance presented the projects as follows:

- Sewer Phase IV – Sewer Phase IV is complete except with the exception of three manholes that needs adjusting.
- Sewer Phase VI – construction in the neighborhood has been completed. The new tanks for the sewer treatment plant should be received within the next month then they can be installed. There are a few complaints which are being addressed.
- LGAP – Handicap sidewalk was approved funding and Mayor Joey Bouziga executed the contract with Clarence Marts Contractors, Inc. Once the rain stops this project should begin.
- North Sewer Treatment Plant has been funded through Capital Outlay and we are waiting on the Cooperative Endeavor Agreement with the State of Louisiana.

Town Attorney Bryce Autin stated he did not have any report.

Mayor Joey Bouziga stated the Board of Health inspected the property of Durvin Lombas, 2400 North Bayou Drive House #B and have issued a compliance order.

Mayor Joey Bouziga commended the field workers for their Hurricane Sally preparations and Mr. Salvador Gonzalez, Jr., for creating a temporary fix to stop the water from coming out of the drainage trap near the Golden Meadow Middle School. DOTD is working on a permanent solution to the problem. Mayor Joey Bouziga stated he and Mr. Gonzalez met with a couple of businesses to discuss the Town monitoring their generators during hurricanes until they are able to get to their businesses to reopen.

Councilman Laci Latiolais informed the Council during the swimming pools off season, we will drain the swimming pool wash it down and refill it with fresh water.

Mayor Joey Bouziga presented the Council with the August Budget to Actual Finance Report to review before the next Council meeting.

Mr. Kevin Cheramie addressed the Mayor and Council regarding his run for Councilman in the upcoming election.

With no further business, Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving this meeting adjourn at 7:14 P.M. The Council unanimously approved the motion as presented.
