The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on November 16, 2020 at 7:00 P.M. at the LaSalette Center 723 North Bayou Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called the meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Willis Toups presented a motion and Councilman Laci Latiolais seconded approving the minutes from the previous meetings held November 2, 2020 and November 9, 2020. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented Building Permit Application preliminary designs for Morris Hunter and Gaubert Oil RV parks. Mayor Joey Bouziga requested Councilmen review the drawing and present any questions or concerns before turning the designs over to the Planning and Zoning Commission.

Mayor Joey Bouziga informed the Council no Occupational Licenses were submitted for approval.

Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV no changes.
- Sewer Phase VI The plant should arrive sometime around Thanksgiving and will be installed once it has arrived. We have a complaint at 178 Rue Pouche Vide which has been inspected by the Building Inspector. The report will be emailed to the Council for review.
- Handicap parking in Oakridge Park- Mayor Joey Bouziga will contact the contractor. The contractor has been delayed because of Hurricane Zeta.
- Upgrades to the North Sewer Treatment Plant is waiting on paperwork from the State.

Attorney Bryce Autin presented the legal report as follows:

• Blue Line Solutions – the committee has not been able to meet to discuss, but there is a second proposal for the automated speed control camera system.

Durvin Lombas – 2400 North Bayou Drive, House #B waiting on compliance order from Board of Health.

Mayor Joey Bouziga presented the September and November Budget to Actual Report for review.

Mayor Joey Bouziga asked the Council to approve an advertisement to thank all the volunteers who helped after Hurricane Zeta. Councilman Jody Cheramie and Councilman Willis Toups seconded approving the advertisement. The council unanimously approved the motion as presented.

Mayor Joey Bouziga called for other business to be discussed.

Councilman Laci Latiolais asked when missing and burnt lights would be replaced. The Town Clerk stated burnt lights are being submitted as they are reported. Mayor Joey Bouziga stated Entergy will be working on poles and lights in phases.
