The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, May 3, 2021 at 8:07 P.M. at the LaSalette Center, 723 North Bayou Drive, Golden Meadow, LA 70357 a special meeting place due to Covid-19. The meeting was delayed due to a lengthy Public Hearing regarding the installation of an automated speed camera.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and Pastor Matthew Chouest led everyone in prayer.

Councilman Laci Latiolais presented a motion and Councilman Kip Plaisance seconded approving the minutes from the meeting and Public Hearings held on Monday, April 19, 2021. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested the Council move item D1 automated speed camera to the beginning of the agenda. Mayor Joey Bouziga requested audience comments or questions in opposition in moving item D1 to the beginning of the agenda. Councilman Laci Latiolais presented a motion and Councilman Kip Plaisance seconded approving Mayor Joey Bouziga to move item D1 to the beginning of the agenda. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga requested the Council present their opinions regarding the automated speed camera. Mayor Joey Bouziga and all Councilmen voiced their concerns and opinions on the automated speed camera.

The motion failed due to a 3/2 vote in opposition of moving forward with negotions.

Mayor Joey Bouziga presented the Building Permits as follows:

 Rose Plaisance- A meeting will be scheduled for the first meeting in June for re-zoning.

Mayor Joey Bouziga stated no Occupational Licenses were submitted for approval.

Town Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV- Engineer has no progress on Sewer Phase IV, Mayor Joey
 Bouziga recommended giving 30 days to complete Sewer Phase IV.
 Councilman Laci Latiolais presented a motion and Councilman Willis Toups
 seconded accepting the Mayor's recommendation to give the engineer 30
 days to complete the project Sewer Phase IV. The Council unanimously
 approved the motion as presented.
- Sewer Phase VI- Sewer Phase VI is completed Change Order No. 2 was
 presented requesting additional days but no additional funds. Councilman
 Jody Cheramie presented a motion and Councilman Kip Plaisance seconded
 approving Change Order No. 2 and the completion of Sewer Phase VI. The
 Council unanimously approved the motion as presented.
- Upgrades to the North Sewer Treatment Plant- waiting on the State to return the paperwork.
- Sewer Phase VII- Town Clerk Jamie Liner stated the Town will receive a grant for \$990,000.00. Mayor Joey Bouziga requests Sewer Phase VII remain on the agenda. Councilman Jody Cheramie presented a motion and Councilman Willis Toups seconded approving Sewer Phase VII remain on the agenda. The Council unanimously approved the motion as presented.

Attorney Bryce Autin advised he had no new business to report.

Chief Troy Dufrene informed Mayor Joey Bouziga and the Council he had nothing to report.

Mayor Joey Bouziga informed the Council he's waiting on an appraisal of the Civil Defense Building.

Councilman Jody Cheramie presented a motion and Councilman Kip Plaisance seconded approving the appointment of Carroll Terrebonne to the Lafourche Parish Council on Aging. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded to approve the February and March Budget to Actual Finance Report. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the dangerous building reports as follows:

Councilman Mike Billiot presented a motion and Councilman Jody Cheramie seconded approving the advertisement of the RFQ. The Council approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion authorizing Mayor Joey Bouziga execute the DOTD Maintenance Agreement for the fiscal year July 1, 2021 ending June 30, 2022. The Council unanimously approved the motion as presented.

Councilman Kip Plaisance presented a motion and Councilman Laci Latiolais seconded the motion to approve Roxxy Pitre be appointed to take and complete minutes under the supervision of the Town Clerk. The Council unanimously approved the motion.

Councilman Jody Cheramie requested adding to the agenda in reference to garbage cans. Mayor Joey Bouziga requested audience comments or questions in oppositions to adding the aforesaid to the agenda. Councilman Mike Billiot presented a motion and Councilman Jody Cheramie seconded approving Councilman Jody Cheramie add garbage cans to the agenda. Councilman Jody Cheramie stated he has garbage can lids if anyone needs their lids replaced. The Council unanimously approved the motion.
