The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, May 17, 2021 at 7:00 P.M. at the LaSalette Center, 723 North Bayou Drive, Golden Meadow, LA 70357 a special meeting place due to Covid-19.

Those present were: Mayor Joey Bouziga Councilman Mike Billiot Councilman Laci Latiolais Councilman Kip Plaisance Councilman Willis Toups

Those absent were: Councilman Jody Cheramie

Others attending were Bryce Autin, Chief Troy Dufrene, Nicol Dufrene, Conner Felarise, Salvador Gonzalez, Jr., Bradley Landry, Jamie Liner, Daniel Lorraine, Roxxy Pitre, John Plaisance, Kitty Prudhomme and Carroll Terrebonne.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and John Plaisance led everyone in prayer.

Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded approving the minutes and Public Hearing held on Monday, May 3, 2021. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the Building Permits as follows:

• Rose Plaisance- A Planning and Zoning meeting is scheduled for June 7, 2021 at 6:15 P.M. for re-zoning.

Mayor Joey Bouziga stated no Occupational Licenses were submitted for approval.

Town Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV- John Plaisance continues to work on the manholes.
- Sewer Phase VI- Construction is complete and waiting for the lien period to expire.

- Upgrades to the North Sewer Treatment Plant- waiting on the State to approve Capital Outlay.
- Sewer Phase VII- Funding was approved from LCDBG.

Attorney Bryce Autin advised the Board of Adjustments will meet Tuesday, May 25, at 1:00 PM at the Golden Meadow Town Hall.

Chief Troy Dufrene informed Mayor Joey Bouziga and the Council he had nothing to report.

Town Clerk Jamie Liner informed the Council an appraisal of the Civil Defense Building was scheduled for May 12, 2021 and the Town of Golden Meadow has not received a response yet.

Mayor Joey Bouziga informed the Council that the Dolphin Marine Building is totaled, they just waiting on the insurance. The Council agreed that the building either needs to be repaired or demolished. Councilman Laci Latiolais presented a motion and Councilman Kip Plaisance seconded agreeing that a letter needs to be sent to the owner giving a 14 day timeline. Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded requesting the Building Inspector to go out to inspect the building. The Council unanimously approved the motions as presented.

Councilman Mike Billiot informed the Town Council that the Contractor is no longer interested in reaching a deal with the owner of the Irvin "White" Cheramie property. Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded the motion to send Mrs. Elaine Cheramie a letter to attend the next Town Meeting on June 7, 2021, if she cannot attend she should speak to Mayor Joey Bouziga or Town Attorney Bryce Autin. The Council unanimously approved the motion as presented.

Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded the motion to contact Board of Health in reference to the property at 505-C North Bayou Drive. There is raw sewerage leaking on the ground under the house. The Council unanimously approved the motion as presented.

Councilman Kip Plaisance presented a motion and Councilman Laci Latiolais seconded the motion to advising 142 Malgum Lane is a dangerous building. The Council requested the Building Inspector go out to inspect the building. The Council unanimously approved the motion as presented. Minutes May 17, 2021 Page Three

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion to send the Building Inspector out to 122 Delgrandile Lane. The Council requested to send a letter to the property owner. Voting is as follows: Yeas: Councilman Laci Latiolais, Councilman Kip Plaisance and Councilman Willis Toups; Nays: none Abstained: Councilman Mike Billiot; Absent: Councilman Jody Cheramie.

Mayor Joey Bouziga informed the Council that Mr. Randall Plaisance is requesting a street light on an empty lot with a pole not wired for a light. Councilman Kip Plaisance questioned whose expense the light would be. Mayor Joey Bouziga advised the Council Entergy will be contacted to go out.

Councilman Laci Latiolas requested adding to the agenda in reference to the mobile home located at 152 Armand Street and Councilman Willis Toups seconded. Mayor Joey Bouziga requested audience comments or questions in opposition to adding the aforesaid to the agenda. Councilman Laci Latiolais requested we take the next step on getting quotes to demolish the mobile home at 152 Armand Street due to passing the deadline for the mobile home to be moved. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion authorizing Town Attorney Bryce Autin to revise the Ordinance regarding junk yards. The Council unanimously approved the motion as presented.

Councilman Willis Toups requested adding to the agenda in reference to a motorhome blocking Theriot Street and Councilman Kip Plaisance seconded the motion. Mayor Joey Bouziga requested audience comments or questions in opposition to adding the aforesaid to the agenda. Councilman Willis Toups questioned Chief Troy Dufrene about a motorhome blocking Theriot Street. The Council advised if the motorhome is blocking a public street it either needs to be moved or towed. The Council unanimously approved the motion as presented.

Councilman Laci Latiolais advised the Mayor and Councilmen on several occasions a utility trailer is parked on North Second Street.

Councilman Kip Plaisance informed the Council there is remaining debris from a house fire on Louviere Lane. Mayor Joey Bouziga advised we will send out a letter to the property owner. Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded. The Council unanimously approved the motion as presented.

Councilman Mike Billiot informed the Council that the Tier 3 Finance Report is due today.

Mayor Joey Bouziga requested audience comments.
