The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, July 5, 2021 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and John Plaisance led everyone in prayer.

Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded approving the minutes of the regular meeting held on Monday, June 21, 2021. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga stated no Building Permits were submitted for approval.

Mayor Joey Bouziga stated no Occupational Licenses were submitted for approval.

Town Engineer John Plaisance presented the project status report as follows:

- Sewer Phase IV- Tops for catch basins should be put in within the next one or two meetings. SBL Construction will be conducting the job.
- North Sewer Plant Upgrades- Waiting on the approval from the State.
- Sewer Phase VII- Waiting on servitudes.

A Public Hearing will be held on July 19, 2021 for the Planning and Zoning Commission to discuss the re-vision to the Zoning Ordinance in relation to building setbacks.

Mr. & Mrs. Richard Olivier was granted at the meeting of June 21, 2021 30 days to clean up the property at 142 Malgum Lane.

Councilman Laci Latiolais presented a motion and Councilman Kip Plaisance seconded requesting to send a letter to give the property owner 30 days to complete demolition at 122 Delgrandile Lane. Mayor Joey Bouziga requested the status on abandoned vehicles. Chief Troy Dufrene advised Mayor Joey Bouziga and the Council he's still working on it.

Mayor Joey Bouziga informed the Council that bids were received to demolish the mobile home at 152 Armand Street. The bids are as follows GIS \$ 7,927.00, E&L Enterprise \$6,221.87, Cooper Construction \$6,500.00 and SBL Construction \$5,800.00. Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded awarding the bid to SBL Construction. Town Attorney Bryce Autin will draw up a contract. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga advised the Council we will wait until an Ordinance is in effect until we do something with the John Parker property.

Mayor Joey Bouziga requested to keep 115 Mrs. Thomas Pitre Lane on the agenda and to take the next step to move forward and have Town Attorney send a letter to the property owner.

The Mayor thanked the Town crew for working during the rain storm the previous night.

Councilman Willis Toups requested a letter of condolences be sent to Town Clerk Jamie Liner and family.
