The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, April 18, 2022 at 7:00 P.M. at the Golden Meadow Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and John Plaisance led everyone in prayer.

Councilman Mike Billiot presented a motion and Councilman Kip Plaisance seconded the motion as presented approving the minutes of the Regular Meeting held on April 4, 2022.

Mayor Joey Bouziga stated there were no Occupational Licenses submitted for approval.

Mayor Joey Bouziga stated there were no Building Permits submitted for approval.

Town Engineer John Plaisance John Plaisance presented a project update:

Town Attorney Bryce Autin advised there is no update on 505-C North Bayou Drive.

Town Attorney Bryce Autin advised he reached out to the contractor for the Picciola Bridge.

Chief Troy Dufrene presented the police stats for March.

Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded the motion as presented to purchase new tasers for the Police Department. The tasers are \$14,400 to purchase out right or \$2,880.07 under a yearly contract. The Council agreed to purchase the tasers out right. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion as presented to advertise for a full time Police Officer. Chief Troy Dufrene requested advertising on the Internet. The Council unanimously approved the motion as presented.

Councilman Mike Billiot requested adding to the agenda The Port Commission donating 5 laptops to the Town of Golden Meadow and Councilman Willis Toups seconded the motion as presented. Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion as presented to accept the donation. The Council unanimously approved the motion as presented.

Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded the motion to open the floor for discussion to accept the \$8,000 bid for the appraisal of the CD Building. Voting was as follows: Yeas: Councilman Mike Billiot; Nays: Councilman Kip Plaisance, Councilman Willis Toups and Councilman Laci Latiolais Absent: Councilman Jody Cheramie. Councilman Laci Latiolais presented a motion and Councilman Kip Plaisance seconded the motion as presented to have the CD Building appraised by a commercial appraiser. Voting was as follows: Yeas: Councilman Kip Plaisance, Councilman Willis Toups and Councilman Laci Latiolais; Nays: Councilman Mike Billiot; Absent Councilman Jody Cheramie.

Mayor Joey Bouziga stated 142 Malgum Lane is in the process of getting cleaned up.

Town Engineer John Plaisance advised Mayor Joey Bouziga and the Council that the permit for 115 Mrs. Thomas Pitre Lane has been approved but not yet paid for.

Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded the motion as presented to fine Mr. Parker for failing to comply with clean-up. The Council unanimously approved the motion as presented.

Mayor Bouziga advised the Council of a phone conference with FEMA, some progress was made. The estimates should be done in a couple weeks.

Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded the motion as presented to give Mr. Terry Gaudet of 2018 South Bayou Drive 60 days to clean up the property. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga advised the Council he spoke to Ms. Martha Daigle of 1914 South Bayou Drive, the camper has been moved and FEMA will be tearing down the house.

Councilman Kip Plaisance presented a motion and Councilman Willis Toups seconded the motion as presented to give Mrs. Dana Friloux of 115 Anatole Lane 60 days to clean up the property. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Laci Latiolais seconded the motion as presented to approve A Written Resolution to Authorize Newly Elected Officials and Remove Previous Administration for Signing Signature Cards for Town of Golden Meadow Building Fund Checking Account at United Community Bank. The Council unanimously approved the motion as presented.

Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion as presented to approve the March Budget to Actual Finance Report. The Council unanimously approved the motion as presented.

Chief Troy Dufrene advised Mayor Joey Bouziga and the Council there is no way to cut overtime in the Police Department schedule due to being short staffed.

Councilman Kip Plaisance presented a motion and Councilman Laci Latiolais seconded the motion as presented to declare the following items as surplus junk:
