Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Mayor Joey Bouziga instructed everyone to refrain from cell phone use until the meeting adjourns and asked that everyone sign the sign-in sheet.

Councilman Willis Toups led everyone in reciting the Pledge of Allegiance and Edward Louviere led everyone in prayer.

Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded the motion approving the minutes of the Public Meeting held on March 6, 2023 as presented. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the following Building Permits submitted for approval:

• Polly Cheramie and Alan Cheramie Exempt Trust Division-Town Engineer John Plaisance advised Mayor Joey Bouziga and the Council that they have some property at the end of Tamplain Ln that they want to split up differently than what

> they have currently, so this is something that the Council will vote on to send to the Planning and Zoning Commission. Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion to send Polly Cheramie and Alan Cheramie Exempt Trust Division to the Planning and Zoning Commission as presented. The Council unanimously approved the motion as presented.  Lou's Rentals LLC RV Park-Town Engineer John Plaisance advised Mayor Joey Bouziga and the Council that the RV Park owner wants to expand to the back so it will reach the highway now, so this is something that the Council will vote on to send to the Planning and Zoning Commission as well. Councilman Willis Toups presented a motion and Councilman Kip Plaisance seconded the motion to send Lou's Rentals LLC RV Park to the Planning and Zoning Commission as presented. The Council unanimously approved the motion as presented. Mayor Joey Bouziga stated there were no Occupational Licenses submitted for approval.

Town Engineer John Plaisance presented the project status report as follows:

- North Sewer Plant Upgrades-State approved plans and specs; should begin advertising week of March 13. We have already began advertising, though Town Engineer Plaisance doesn't remember the exact date. We will have a preconstruction conference on Thursday, 3/30/2023 and the bids are due on Thursday, 4/13/2023.
- Sewer Phase VII LCDBG-awaiting servitude acquisition and subsequent advertising
- Mitigation Project (Seawall)-met with Lafourche Parish Government on 1/17/2023; approved by the State and awaiting Federal approval
- LGAP Grant application (Police Unit)-submitted on 11/21/2022
- Infrastructure Grant applications-BRIC and Flood Mitigation Assistance Program submitted on 12/19/2022; still under review
- Consider authorizing the Mayor to sign a resolution to authorize GIS Engineering to submit a pre-application for the Clean Water State Revolving Fund to seek loan information, terms and potential subsidy money for certain Sewer projects. Town Engineer Plaisance advised that we would be submitting 2 pre-applications-1 essentially just for Cheramie Ln for around \$600,000 and 1 for Phase 8, which would

> be for Cheramie Ln, but would also include Washington St and Pershing Ln for \$2,800,000. The State would then come back with terms to let us know what we have to pay over a 20-year period and what subsidy money we would receive. Technically we are applying for a loan for the whole thing, but they have money available to knock off some or all of those loan costs, so we won't know how much until we get the pre-application in. Councilman Willis Toups asked so we are at the mercy of the State to find out when and where. Town Engineer Plaisance advised that was correct and we will probably ask for 100% for both, but it will depend on economic factors. The pre-applications are due Friday, 3/31/2023. Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded the motion authorizing Mayor Joey Bouziga to sign a resolution to authorize GIS Engineering to submit a pre-application for the Clean Water State Revolving Fund to seek loan information, terms, and potential subsidy money for certain Sewer projects as presented. The Council unanimously approved the motion as presented. Town Attorney Bryce Autin's Attorney Report:

- Discuss Policy on New Hire Reimbursement (90-day clause) (Committee: Kip Plaisance/Willis Toups)-Town Attorney Autin spoke with Assistant Town Attorney Jeray Jarreau, who met with the committee this afternoon, and said there was one more revision she would like to make and meet with the committee again prior to bringing it before the full Council. Councilman Willis Toups advised Mayor Joey Bouziga and the Council that they went over everything and made a few changes that they would like to see incorporated in it.
- Discuss Remote Work Policy (for remote working during office hours) (Committee: Mike Billiot/Kip Plaisance)- Town Attorney Autin spoke with Assistant Town Attorney Jeray Jarreau, who met with the committee this afternoon, and she had something to search and wants to meet with the committee again before the next Council meeting, before presenting it to the Council.
- Discuss GM Ordinance No. 437 regarding payment of health insurance premiums for certain retirees-there is something else Town Attorney Autin wants to research before bringing it back up to the Council.
- Consider approving Ordinance No 541 repealing Ordinance No. 525 regarding town curfew-Town Attorney Autin reiterated that this has nothing to do with the juvenile curfew, but the curfew put into place in 2020 to address a specific issue, that has since seemed to have subsided. Town Attorney Autin recommends passing Ordinance No. 541, which would repeal Ordinance No. 525. Councilman Willis

> Toups presented a motion and Councilman Mike Billiot seconded the motion to approve Ordinance No 541 repealing Ordinance No. 525 regarding Town curfew as presented. The Council unanimously approved the motion as presented. Chief Troy Dufrene's Police Business:

 Report on Speed Humps for Cheramie Ln, Washington St, and Dursette St-Chief Dufrene spoke to the Motorcycle Cop who's in charge of the data. He managed to get the data off of the jump drives. He is getting his equipment ready and is supposed to get with Chief Dufrene this week to see what streets we need equipment down, so Chief Dufrene is waiting on that call. Lafourche Parish Councilman Daniel Lorraine recommends passing a resolution with the seed humps and send it to the parish council, so it can get paid by Road Sales Tax 2. Town Citizen Edward Louviere stated that with State Bank opening at the back of Washington St, it will make a lot more traffic going down Washington St than ever before, so he believes we should be able to get the speed humps down all 3 streets. Councilman Mike Billiot brought up that we may not have to follow the Parish's guidelines since we are Golden Meadow. Mayor Joey Bouziga agreed, but stated that we need to be careful because then every street may want speed humps. Town Citizen Patricia Louviere stated that they will have more traffic once the new Dollar General opens up. Town Citizen Trixie Allemand stated that people will avoid Washington St if they have speed humps and end up taking the next street, so the whole neighborhood will want them after a while. Councilman Mike Billiot presented a motion and Councilman Willis Toups seconded the motion to pass a resolution asking for the Parish to pay for speed humps down Cheramie Ln, Washington St, and Dursette St from Road Sales Tax 2, if the streets meet the criteria as presented. The Council unanimously approved the motion as presented. Town Clerk Tracee Cloutier advised Mayor Joey Bouziga and the Council that the notice sent to appear at the 3/6/2023 meeting came back undeliverable. Town Attorney Bryce Autin advised Mayor Bouziga and the Council that we will need to set a hearing for

4/17/2023. Councilman Mike Billiot presented a motion and Councilman Kip Plaisance seconded the motion to issue notice for a condemnation hearing on 4/17/2023 as presented. The Council unanimously approved the motion as presented. Mayor Joey Bouziga advised the Council that they completed the equipment building at the park and the pumping station and they are welding clips on there. We are still waiting on a 3<sup>rd</sup> price for the lift station. Our last meeting with FEMA was very positive. Councilman Willis Toups asked if there was a target date to put the turf in at the park and Mayor Bouziga let him know they are waiting for the cement to cure.

Report on 2609 North Bayou Drive GM (Huey Cressionie)-advertised for tall grass and debris on 1/12/2023 and 1/13/2023-consider hiring contractor to remove debris and cut grass; hired DTB General Contractors and job complete as of 3/16/2023. Mayor Joey Bouziga thanked Farrell Trahan for doing a good job on the property. Councilman Mike Billiot presented a motion and Councilman Kip Plaisance seconded the motion to remove 2609 North Bayou Drive from the agenda as presented. The Council unanimously approved the motion as presented. Mayor Joey Bouziga advised the Council that Polly Cheramie called him and said she couldn't do anything, but she didn't want to go to jail. Mayor Bouziga told her the next step will be for us to hire a contractor and put the bill towards your property tax. Councilman Willis Toups asked if that was the same property they want the division on. Town Attorney Bryce Autin stated he believed it was the next property on the agenda that they want the division approved on. Mayor Bouziga recommends advertising to get the property cleaned up and cut.
