**Mayor's Report:**

A motion to authorize Mayor Bouziga to proceed with pump station engine repairs, as presented, was made by Council Member Billiot; seconded by Council Member Cheramie. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: Toups.

Building Permits: Chairman McNeely Rome from the Board of Adjustments advised that they recommend approving Richard Strickland's variance request, after discussing with the Board of Adjustments and Town Engineer John Plaisance; with the stipulation that he installs a 1-hour firewall between the trailer and house. A motion to accept the Board of Adjustment's recommendation, as presented, was made by Council Member Cheramie; seconded by Council Member Plaisance. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: Toups.

- North Sewer Treatment Plant Upgrades-Work in progress and the deadline to complete is 5/31/2024.

- Sewer Phase VII LCDBG (Terrebonne & Delgrandile)-On 4/2/2024, the contracts were executed, but the contractor is having trouble getting the bonds.
- Mitigation Project (Seawall)-GOHSEP approved it, working on overturning FEMA's rejection or finding another funding source-is in touch with the Senate's office.
- Infrastructure Grant applications (FMA)-GIS is coordinating with FEMA and GOHSEP.
- Clean Water State Revolving Fund (Sewer Phase VIII (8)) (Cheremie)-Town Attorney Jeray Jarreau is getting together the servitude agreements.
- Capital Outlay-Replacement of Sewer Lift Station behind Williams Road-Planning and Construction; FP&C approval was received for advertising and bids will be opened on 5/23/2024.
- Capital Outlay-Armand/Alcide Area Drainage-Planning and Construction; Town Engineer Plaisance met with the Mayor, Council Member Billiot, Town Foreman Salvador Gonzalez, Jr., Sewer Foreman Drake Rogers Jr., and Town Clerk Tracee Cloutier to talk about the next steps. They discussed adding a pumping station with the pump costing around \$100,000.00. Town Engineer Plaisance will put together a couple of packages one-with a pump on the bayou side; and one with a pump on the bayou side and a pump on the front side.
- Town Engineer Plaisance advised that 9 Capital Outlay requests for the fiscal year 2024-2025 were submitted on 10/31/2023 and we are waiting for them to go through the legislative process which will be in June 2024.
- Chlorine Contact Chamber at the South Plant will need to be replaced. Town Engineer Plaisance advised they are still waiting on a quote from STAT.

### Town Clerk Tracee Cloutier presented the Attorney's Report:

- 1504 S. Bayou Dr. (Walter Guidry and Martin Perkins)-Condemnation hearing 4/15/2024. Attorney Craig Stewart and Martin Perkins are present. SCPDC's Building Inspector Joseph Cehan reported that there have been some improvements, but there is still a lot to be done. A motion to issue a 30-day condemnation order, with a deadline of 5/20/2024, as presented, was made by Council Member Latiolais; seconded by Council Member Billiot. A roll call vote took place as follows: YEAS: Cheremie, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: Touns. Mayor Bouziga advised Attorney Stewart and Mr. Perkins that they should get a permit to make sure everything is done to code.
- Town Clerk Cloutier discussed the possibility of Tamplain Lane being turned back over to the Town with the Mayor and Council. Town Attorney Autin advised Town Clerk Cloutier via email that the paperwork is drafted, and he is waiting on Town Engineer Plaisance's office to finalize the map and get property descriptions to use with the agreement. Town Engineer Plaisance's office will not proceed until Marc Cheremie signs the proposal to do this work for \$3,500. The reason for the drainage servitude and the new map is because we want to make sure we have everything surveyed properly and we will need a way to drain that street, since the town will be spending money eventually to improve and maintain Tamplain Lane.
- The meeting to discuss TOGM's policies and procedures: Communication Policy, Grievance Policy and Hostile Work Environment will be the morning of 4/17/2024 with Attorney and previously picked committee-Council Member Plaisance and Council Member Cheremie.
- Town Attorney Autin advised Town Clerk Cloutier via email that they are still working on the bid packet for demolition of condemned buildings.
- A motion to approve the First Amendment to the Cooperative Endeavor Agreement with South Central Planning Development Commission, as presented, was made by Council Member Plaisance;

seconded by Council Member Latiolais. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: Toups.

Police Chief Troy Dufrene presented the Police Business:

- Update on Speed Humps-Cheramie Lane is complete and they are almost done with Dursette Street, Washington Street, and Pershing Street. Chief Dufrene is still waiting on the reports.
- Police Department Equipment-Chief Dufrene advised that they had a Zoom meeting for the dash cameras. It is in process and will take a couple of months. Once it starts, they will do the installation here and they are coordinating with Expert Technology.
- LPSO to put speed reader on North Bayou Drive-Chief Dufrene advised that we are still waiting on an available reader. A motion to remove LPSO to put speed reader on North Bayou Drive-due to the Chief's recommendation, as presented, was made by Council Member Cheramie; but there was no second made, so therefore the motion failed. Council Member Latiolais asked who the contacts are for the speed reader and Chief Dufrene advised they are Elliott Day and Andrew Labat.
- Police Employee Benefits to be discussed in a meeting with Council Member Toups and Council Member Billiot. A motion to replace Council Member Toups with Council Member Latiolais, so a meeting date can be determined, as presented, was made by Council Member Plaisance; seconded by Council Member Latiolais. Mayor Bouziga advised the Council that they are working with FEMA to consider relocating the Pump Station shed to the Maintenance Building behind Town Hall.

Bidder was advised that scope specifications were not clear, so requesting to go out for Re-Bid with more detailed scope specifications. Mayor Bouziga advised the Council that we are submitting invoices as they are complete for the Lafourche Parish Hurricane Ida Recovery Grant with a deadline of 6/30/2024. On 4/8/2024, we received \$11,042.76, so \$195,345.07 is remaining.

Mayor Bouziga advised the Council that the Parish will request bids in the 2<sup>nd</sup> or 3<sup>rd</sup> quarter of 2024 to repair the asphalt on Ridgewood Boulevard, Doucet Drive, and Norman Street.

Mayor Bouziga advised the Council that the LGAP application was submitted on 11/13/2023 and the results are expected July/August 2024.

Mayor Bouziga advised the Council that Mandatory Fuel Management stated there is nothing wrong with the gas, so we are putting more fuel in the tank to continue testing.

Lafourche Parish Fire District 3 Chief Devin Dedon asked for the community's support for the fire millage ballot and advised that early voting is going on now. He also stated that the condemned fire station is being torn down starting on 4/18/2024. He advised there was a fire at 128 Paul Street that the Fire Department knocked out in 6 minutes with the help of GMPD, Lafourche Ambulance, and Harbor Police. He asked if it can be added to the condemnation list due to citizens calling to complain that it is unsafe.
